#### **SCHEDULE TWO - BY LAWS**

Oceania Kung Fu Wushu Federation Limited Ordinary and Associate Membership Criteria Membership Administration Voting Delegates International Appointees

# So authorised by the Board in accordance with the Constitution of the Oceania Kung Fu Wushu Federation Limited to be effective from 1.7.17

The Board recognises that the 'Foundation Members' of the Oceania Kung Fu Wushu Federation Limited are:

Kung Fu Wushu Australia Limited New Zealand Kung Fu Wushu Federation Papua New Guinea Kung Fu Wushu Association Kung Fu Wushu Vanuatu

A 'Foundation Member' shall be recognised as an 'ordinary (full voting) member'.

The following membership categories shall be recognised for subsequent members:

- 1. Ordinary (Full Voting) Member
- 2. Associate Member

# 1. ORDINARY (FULL VOTING) MEMBER

Full Membership confers voting rights and shall be open to the organisation that represents the Kung Fu/Wushu in an Oceania country or protectorate. Said 'member organisation' shall be a 'registered entity' and shall agree to the following:

- a. the 'member organisation' shall be a financial member of IWUF
- b. the 'member organisation' shall be a financial member of OKWF
- c. the 'member organisation' shall be recognised by the appropriate 'recognition body' relevant to the country or protectorate of the 'member organisation'
- d. the 'member organisation' will be bound by the OKWF Constitution By Laws and all Operational and Policy documents so authorised by the Board
- e. the member's organisation and all of its affiliates, members, instructors and employees (whether paid or unpaid), if engaged in competition, will be bound by the OKWF Anti Doping Policy
- f. To have a Constitution that is approved by OKWF
- g. The 'member organisation' will have entered athletes and officials in the official Oceania Kung Fu Wushu Championships

h. The 'member organisation' will have conducted a OKWF sanctioned National Championship event in their country

## 2. ASSOCIATE MEMBER (1)

Associate Membership does not confer voting rights and shall be open to the organisation that represents the Kung Fu/Wushu in an Oceania country or protectorate but that cannot yet meet the requirements to be a full member. It is expected that an Associate member will work with OKWF to achieve full membership. Said members organisation shall be a 'Registered Entity' and shall agree to the following:

- a. the 'member organisation' will be bound by the OKWF Constitution By Laws and all Operational and Policy documents so authorised by the Board
- b. the member's organisation and all of its affiliates, members, instructors and employees (whether paid or unpaid), if engaged in competition, will be bound by the OKWF Anti Doping Policy
- c. To have a Constitution that is approved by OKWF
- d. the 'member organisation' shall be a financial member of OKWF

## 3. MEMBERSHIP ADMINISTRATION

- a. All membership criteria must be verified
- b. Any member who is unable to establish compliance with all Ordinary Membership criteria will deemed to be an Associate Member until the renewal form is lodged and criteria compliance is subsequently verified.
- c. Registered Entity: It accepted that there is a wide variety of what may constitute a 'registered entity' within the different countries within Oceania. Accordingly what is acceptable in the country that the member association represents is acceptable to OKWF.
- d. Recognition Body: It is accepted that there is a wide variety of what is the appropriate "Recognition Body' within the various countries within Oceania. In some countries it is a government sports department, in others it is the Olympic Committee, in others a combination of both. Accordingly what is acceptable in the country of the member association is acceptable to OKWF.
- e. Members of an OKWF Association may not also be members of another organization deemed to be a 'conflicting organisation' by OKWF or IWUF. OKWF and its member Associations deem an organisation to be 'conflicting' if:
  - i. the organization has in its membership a person or business entity effectively or largely controlled by a person who has been expelled from any of its member Associations or
  - ii. it is an organisation that misrepresents itself as the body purporting to govern kung fu/wushu in Oceania or in an Oceania country

- iii. is an organisation who in the opinion of OKWF and/or its member Associations has acted in a manner contrary to the interests of the OKWF and its member associations or
- iv. is an organisation that is a member of an organisation that is or has acted in a manner to bring IWUF or OKWF into disrepute or
- v. is an organisation or that is a member of any organisation, that has been named as a 'conflicting organisation' by OKWF or IWUF or any of its member associations

## 3. VOTING DELEGATES

- a. Each OKWF ordinary member or foundation member shall be entitled to provide a voting delegate to the OKWF AGM.
- b. A voting delegate shall be the President of the OKWF member organization or his/her appointee (subject to provisions 3.c).
- c. A voting delegate must be a member of the organization so nominating the delegate and must hold a passport issued by that country.

#### 4. INTERNATIONAL APPOINTEES

- a. Any OKWF appointment to an IWUF Committee or Executive Board position can only be filled by a person so nominated that holds a passport issued by an Oceania country
- b. A person who currently holds an Executive position with another IWUF recognized Continental Federation may not hold any Oceania representative IWUF Executive Board or Committee position.
- c. A person having held an Executive position with an IWUF recognized Continental Federation, other than OKWF, but having resigned from that position shall, subject to the additional provisions of 4.a., be eligible to fill an Executive Board or Committee position five years after the resignation has been tendered.
